Meeting call to order: 10:25 am

Pastor Tom led in prayer

Attendance: 35 people, Quorum met

Approval of minutes: Paul Christenson motion to approve, Mary Hershof 2nd, all approved

Pres report: Genesis 12 "I will bless you and all peoples on earth will be blessed through you."

St. Olaf has been a blessing to the committee and to us. Talked about how St. Olaf was chosen as their church. Thanked St. Olaf for being welcoming for them and for those that they brought to St. Olaf. Thanked everyone and every team individually.

Has been impressed by working on the council and the work of property moving pews, worship and music committee, all of staff and custodial staff, musicians, and so many. Thanks for all the work of the cooks and bakers of the Lutefisk Dinner and other events and soup ministry. Very hard-working church.

Caring and sharing ministries working hard and continuing our mission statement "Sharing God's Love and Caring for Committee", locally Milwaukee and the world, central America.

Pastor's report

Came here in 2016 and went through council leadership. Stated appreciation for Mary's hard work and doing another term. Went over report. Stated appreciation for support of their family. We will continue with theme of Sharing Much Fruit.

Church is growing, there are new faces here. There is something going on. Not many churches are growing. Make sure to greet people you may not know. Relationships are important.

We have a strong council which helps us grow, best in Greater Milwaukee Synod. They are involved.

Talked about the Belize mission we have been able to accomplish. We raised \$40,000. in a few weeks. We are blessed. This is an ongoing relationship. Celebrate that. We have more going in the future.

More people have been inviting Pastor and Kris to their homes. Thive team has been helping to build relationships through small groups. John 15 says "abide in me and I will abide in you". Stay connected to the vine, we are the branches and must bear much fruit.

Treasurers report and budget

The budget is in the annual report. This year budget is increased less than 5%. Needed to support staff and increase in expenses such as insurance, etc. Entertained motion.

George motion to approve. Mary 2nd All approved.

Women of Grace and Property / Environmental Impact Cindy Schlieve.

Women of Grace report is complete but want to add that they had \$6,000 to spend again toward 13 missions from the bake sale and Scandi boutique. 11 got \$500 and 2 got \$250. She listed groups that received funds. Added a new group this year, Support the troops. Run by women in Hartford, sends boxes of good things to troops around the world. Book club also donates.

Property: there was resolution passed September "Resolution Regarding the Environmental Impact of Items Accepted and Used at St. Olaf". Read the resolution to attendees. On the to do list is to create a poster to help meet the goal of the resolution. Women of Grace is downsizing, reorganizing areas,

recycle or donate unneeded items. Eliminating and recycling Styrofoam. As for donated items, please check with property or council first so we can determine if we can incorporate it or use it in a project. Alternately there are other places to donate and they encourage those also.

Youth Ministry: Scott and Kristin

Scott first helped with Sunday School shortly after joining. Now helping with high school and Confirmation. We are now doing Sunday School during sermon. This has helped with attendance. During COVID the numbers went down but now are increasing the number of students for VBS and other classes is increasing. Now 23 students Sunday School, 20 for VBS, arts, crafts and music. Christmas program larger, 20 students. New families now in the church allow confirmation classes to increase for older teens. Parents / families are joining the youth. Have been using The Chosen to know Jesus. 7 students for box city, not as cold and a great program to learn about homelessness. Thanksgiving service included youth for music and messages. Have had successful fund raisers. Will be used for mission trips, etc. Indianapolis trip, 8 people, 5 youth with Belize trip, 4 students and moms. Purpose for mission is not just about people that are there but also to grow in faith for those going.

2 students affirm Baptism, 3 graduated from high school, 7 scholarships were awarded. Scholarship fund is growing. Youth Quake coming up next weekend. Montana trip of 11 coming up summer. Adventure, group building trip. Kristin finished up with a look at the future, there will be a ramp up. Montana trip, pie auction, soup contest, and much more going on.

Scrip report: Sonja Daly

Explained Scrip – “free money for the church”. No cost to you, St. Olaf gets money back when used from the companies. This year made \$2553.93 \$1663.75 went back to Child Smile for the cards they purchase for that mission. \$1000 went to the scholarship fund. Went over the amount various cards return to us, from 1.5% to 4% and some special times 9%

Child Smile: Lyn Johnson

No questions during meeting. See report.

Prairie project: Mary Hershoff

This is now in expository stage. Area back of parking lot. We own the field behind also. We have been renting to farmers. We can restore that area to native prairie. Can be used for a variety of uses. Church in Cedarburg has done this and has circle area where children can play or others can gather. Also, can be used for wild church, fire circle, sheltered worship area, etc. This may be a way to attached those not as comfortable in normal church setting. We have people familiar how to do this. Feb. 9th there will be a meeting on this.

Thrive Team: Mary talked about Thrive Team also. Marquette University created a program based on the Examen as the basis. A team was created to work with them. First used individually and then as a group. Team has been working for 2 years. This team was responsible for creating small groups. Also did children’s workshop. 12-13 children came, many helped working with children, chipping in for gifts for parents, cookie baking and decorating, games, etc. good time. Will do again. April 19th another event, still in planning, Saturday before Easter. Another project is that Herb will be building raised bed planting boxes at the end of the patio area. Children can come and plant seeds.

Lyn Johnson: more on Child Smile

Roger would not want Child Smile to be glossed over. Child Smile is alive and well. Mark and Laura Rutkowski took the lead, passed to them by Roger. Heather coordinated with schools. Without them and the team it would not have happened. Roger would be proud to know it continued.

Mission Team: Paul Christenson

Thanked everyone for donations, report on page 26-27. Some funds are designated and some undesignated which the team directs. Totally collected \$89,000 (most of which was for the Belize fund).

Peggy Morrissey raised hand and ask that the mission team consider a regular donation to Partners in Medical Mission. They will be doing a yearly trip to do surgery. The cost is approximately \$25,000-\$30,000 per trip and they would like to expand the surgeries. This year the team donated about \$20,000 to ministries they normally support. Paul suggested that this may be something for the Vision Fund.

Report from Council President

2025: A Year of Giving Generously

Our Stewardship Theme this year, ***Living Generously***, is of course a variation on the wording that appears on our Thrivent T-shirts. But more than just wearing the t-shirts and living generously, you, the congregation, have been ***giving generously*** also. In this report, we will consider the ways your generosity has helped many in need. Similarly, your giving has helped sustain St. Olaf, maintaining a flourishing church here in the Town of Ashippun countryside.

Supporting missions: As in the past, this year we have prayerfully and financially supported several international missions. Our mission team to the Marcus Canul Care Point in Belize has worked there on building projects as well as working with its young people. We have also donated to Partners in Medical Missions and its work in Guatemala. In addition, we continue to support our missionaries in Indonesia and Nigeria. More locally, Randy's Sikkema's work serving homeless and the hungry in Milwaukee at Redeemer Lutheran Church has grown significantly this past year. Similarly, Steve Stretz continues to take fresh vegetables and groceries to All People's Church every Wednesday in the summer and also delivers food and other supplies throughout the year. Hundreds are fed weekly in Milwaukee thanks to these two efforts. Elaine Monis and Justine Cadena deliver freshly prepared food regularly to Family Promise facilities in West Bend, a tradition that St. Olaf has been a part of for many years. And of course, our Soup Troop, led by Susie Grulke (this year by Laura Savatski), delivers homemade soup and bread each month to shut-ins and others in need. A Child's Smile, founded by Roger and Lyn Johnson and now led by Mark and Laurie Rutkowski, once again reached many schools in the area, donating gift cards to 1,237 children. We also contribute generously to the Milwaukee Synod of the ELCA and its international and local mission projects, including Outreach for Hope.

Maintaining our Church Property: Because you have given generously, there have been significant improvements in and around the St. Olaf campus this past year. One of the more obvious is the paving and painting of the church parking lot. Another is a new roof on the church, on the parsonage, and on the garage, projects we had been anticipating for several years, but were accelerated by the hail damage in the spring. Other projects include work on siding, preparing for the Prairie Project with seeding to begin in the spring, and additions to our patio area including Herb Johnson's metalwork and wooden planters.

Welcoming and encouraging new congregants and our youth: Many members have joined this year and we have seen active participation by them and by the young people of the congregation. Hopefully you were able to attend or view online the Thanksgiving Service developed and led by our young adults. This included music, readings, and the sermon very ably delivered by Garrett Monis. Another "must see" was the Children's Christmas program highlighted by the delightful junior Handbell Choir. Young adults and new and longtime members were also busy with the Ice Cream Social in July. In December they baked, served, and bussed tables for the Lutfisk dinner. Special mention should be given to Gavin Monis who worked with his family and Boy Scout Troup to develop the labyrinth in our Prairie area.

Supporting St. Olaf Financially: Giving to the General, Capital and Mission Funds has been strong again this year. Expenses totaled \$241, 686 which was under budget by over \$2000. Two things to note in the 2026 budget: it is lower by about 9%, because Pastor's health insurance will be paid through Kris Pietz's employer this coming year; second, the total amount of pledges this year is lower. This is significant, but we do feel that with sustained giving it will be possible for us to meet our budget. We want to emphasize that there are many Mission Fund needs out there, and the coming year may demand even more of our support.

Overall as we look forward to 2026 and beyond, the future looks bright. Our church and its campus are in great shape. The Prairie Project will add a new dimension not only to our landscape but

to our worship as well. We have a stable, hardworking staff, truly dedicated to serving our Lord. We are exploring a well-deserved sabbatical period in 2027, which will give Pastor Tom time to be renewed and, in addition, it will give us all a time to experience new speakers and new ideas.

In conclusion: I want to recognize and thank the staff, our many volunteers, and the Council who give so generously of their time and talent. Pastor Tom spends hours counseling, preparing for worship, and engaging in activities throughout the community. We have an incredibly efficient secretary in Shannon Lutz. Kathy Johnston is our very able financial secretary. Scott Siegrist helps lead the youth program, assists in worship services, and amazes us with his graphic design talents. Debbie Stephan keeps the building in top shape...and if she's not there working, Jerry Schlieve is. Kris Pietz heads our multi-age Sunday School department. We are blessed by the remarkable musical talents of Clara Birkel, Cathy Paquette, and Steve Stretz. There are many other volunteers serving on committees, in Women of Grace, or assisting at our various fundraisers. St. Olaf is truly blessed to have such an abundance of cheerful, helpful volunteers. Finally, I want to thank the Council, all of whom have been so supportive during the last 2 years that I have served as President. Thank you, Steve Stretz, Dave Johnston, John Christenson, Scott Siegrist, Susie Grulke, Sonja Daly, Ron Egelseer, and of course, Pastor Tom, for your help and especially for your patience. It's been great working with you all!

Let's all look forward to another year of ***Living Generously*** in 2026.

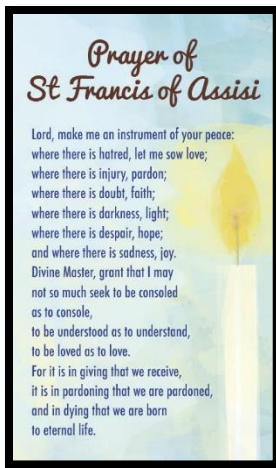

THE 2025 YEAR

St. Olaf's was once again blessed in the 2025 year to be able to hold all of our traditional events such as preparing and serving a meal for those in need (some homeless and some needing extra help) at St. Ben's in Milwaukee, the ice cream social and car show, Blue Grass/Corn Roast event, and the Lutefisk Dinner/Bake Sale & Butik. As we have often said "God is good, all the time! All the time, God is Good!" While the events are an important part of our congregation, we also were able to participate in a variety of other kinds of activities in order to help people in so many ways, which ultimately is a huge blessing to those who receive the help and to those who provide the help. One of those projects is the soup troop which began during 2020 due to the COVID restrictions and is still continuing once a month during the fall, winter, and spring. Thank you to all who participate in making the soup, various kinds of bread, and providing other treats for the boxes that are delivered to those who either need or enjoy having the gift of food and fellowship upon delivery. The response we received from our members, and some guests, toward the preparation of the Lutefisk Dinner/Bake Sale/Butik was once again very welcome. There was an excellent quantity of volunteers who did a fabulous job of making our event in 2025 such a great success! The Women of Grace could not put on an event such as this without all the help from congregation members. We are truly thankful to each and every one of you. At this year's event we served approximately 535 meals; 30 of those were take-out meals, which is a slight decrease from last year. The profits from the bake sale and Butik combined are approximately \$6,720, and the profits from the dinner itself were approximately \$6,699. The profits from the bake sale/Butik will be distributed to a variety of missions at the meeting to be held on January 12, 2026. We will also use that time to review the event. The dinner profits will be used throughout the year for various needs that are made known to us. Again, **THANK YOU** so much for the wonderful involvement of so many people in this past year's events.

BIBLE STUDY

There is a weekly Bible study that is usually held at the home of Jane Christenson on Tuesdays, at 9:00 a.m. The Bible study topics vary, but it is always educational and interesting. On the first Tuesday of each month, we prepare the "Splash" pages that are sent or delivered to children who have been baptized at St. Olaf up until the age of 3. These pages are intended to offer the parents/guardians some

ideas to keep Christ in their families. Currently there are 10 children whose parents receive these pages, plus one child who has not been baptized but is a neighbor to me. On the second Tuesday of each month, we use the monthly study that is included in the "Gather" magazine published by the Women of the ELCA. During a portion of this past year, we used the fifth season of "The Chosen" videos along with its study provided by the writers of the program. It continues to be a very interesting and rewarding study and has shown us new ways in which to view the Bible and I believe it has given us a better understanding of many things. Thank you to Susie Grulke who brought this study to us and continues to do a wonderful job of leading it as well. If you have a desire to spend some time with a lovely group of ladies and learn more about the Bible, please feel free to join us.

MEETINGS

Meetings for the Women of Grace at St. Olaf are held on the second Monday of the months of January, March, May, September, and November. The meetings are generally held at 3:00 p.m. at church. Light refreshments are usually served. All women who are members of St. Olaf are considered members of the Women of Grace and are welcome to attend the meetings or participate in any events that are held. Report from Youth Ministry

The Youth Ministry program continued as a shared leadership effort in support of St. Olaf Youth. Kris Pietz led the Sunday School children, while Pastor Tom Pietz and Scott Siegrist partnered in guiding both confirmation and high school youth. Midway through the year, Kristin Thiel stepped down from her role as youth coordinator. As the youth program continues to evolve and change, the leadership team remains committed to adapting in ways that best serve the needs of youth and their families.

Sunday School – Kris Pietz

First Communion – Instruction began with class and a Seder Meal on April 1st. The youth made Communion bread and decorated their chalices on April 8th. Sophia Ettinger, Beck Sands, Flyn Sands and Keira VanderMolen celebrated their First Communion on Maundy Thursday, April 17, 2025 with families and congregation members present.

Vacation Bible School (VBS) – Our youth had a great day on August 2nd at Cave Quest VBS from 10AM – 3PM! Twenty-two children registered. We had at least that many amazing volunteers as well. Our themes were Jesus give us direction, and Jesus gives us love. Following Jesus, the light of the world. Youth listened to skits, sang songs, did crafts and played games all focused on knowing Jesus more. For our service project, we collected 450 pairs of shoes for Soles For Jesus!

Sunday School – September 7th was our Kick Off event for Sunday School. A variety of activities led by a wonderful group of volunteers provide a pull-out program for children ages 3-12 during the sermon each Sunday.

Christmas Program – *A Savior Is Born* was the name of our Christmas program, and took place during the December 14th worship service. The sixteen children, confirmation and teen helpers involved in this program were a delight to work with and did a fine job sharing the true meaning of Christmas. Thank you to all who stepped in to make this day a success!

Confirmation – Pastor Tom Pietz / Scott Siegrist

The most influential faith leaders in a child's life are not their pastor or even their church, but their parents. With that in mind, our confirmation classes intentionally invite parents to learn alongside their children, participating in discussions, sharing their perspectives, and engaging together in conversations about faith. During the spring session, families journeyed through Seasons 3 and 4 of *The Chosen*, watching episodes at home and then gathering in class to explore the themes and Scripture behind each story. In the fall, our focus shifted to daily Bible devotionals aligned with the Narrative Lectionary and weekly sermons, helping students and families build a habit of daily time in God's Word while digging more deeply into each weekend's message. Each week, we also shared highs and lows as a group, celebrating joys and offering support through the challenges our students encountered along the way.

Three youth - Logan Becker, Gavin Gies and Cecelia Kuzenski received their Affirmation of Baptism on October 25, 2025, Reformation Sunday. Confirmands shared their faith stories and a Bible verse that holds personal significance, explaining how it has influenced their lives. Cake was then shared during fellowship following the service.

Youth Activities & Events

While our core group of confirmation students were actively involved in many of these activities, we also had the welcome participation of older students and families who joined us for several events.

Pie Auction – The youth pie auction fundraiser, held on March 2nd, was generously supported by members, families, and friends through pie donations and purchases. For those unable to stay for the

auction, youth also offered “to-go” containers with select individual pie slices. This fun event raised a record-setting \$4,216 to support youth event opportunities.

Roadside Clean Up – St. Olaf youth and families individually took time to clean up sections of our designated road area from Hwy 67 to the county line on Hwy O, the week of April 20th (Earth Day).

Graduate Recognition – Three graduates were recognized at service on June 1st:

Claire Bingen - Post-graduate plan: attending Waukesha County Technical College, majoring in architectural drafting and interior design

Ella Smithyman - Post-graduate plan: attending UW-Milwaukee with a goal of becoming a residential architect.

Braeden Christenson - Post-graduate plan: attending UW-Whitewater with aspirations of studying business and sports management.

Three additional students were not present for the service: Samantha Uhlman, Ava Walter and Lily Siegmann.

Scholarship Awards – Eight applicants received a \$1000 education scholarship award each and two \$750 scholarships were also given. The monetary awards were funded from the Scholarship Endowment Fund (\$9500). The scholarship monies were sent directly to the student’s college by our Financial Secretary. The recipients were Amiah Brakob, Andrew Hoffmann, Braeden Christenson, Claire Bingen, Ella Smithyman, Garrett Monis, Olivia Otto, Owen Otto, Sally Pietz and Sam Pietz, and they were recognized during the August 3rd service. Scholarship Application/Guideline forms are on the St. Olaf website under Resources and are due by May 1st. The Scholarship Endowment Fund can be supported with planned life giving and other donations which would enable us to increase the amount of an awarded scholarship. The current guidelines allow up to \$1000 scholarship per qualified applicant. For more info or to donate to this fund, contact our church Treasurer, Council president, or Pastor Tom.

Adventure Trip – This summer trip was different from the start... boarding an Amtrak train for the July 11-20 trip to Montana. Attending youth were Garrett & Gavin Monis, Alex & Drew Hoffmann, Adia & Gavin Gies, Bailey Siegrist and Brayson Brown. The chaperones were Pastor Tom, Kristin Thiel and Ben Hoffmann. The group stayed at Flathead Lutheran Bible Camp in Lakeside, Montana. Highlights of the trip were the 30-hour train ride (each way), an overnight hike into the mountains and kayaking out to an island. Our musicians helped to lead large group worship at the Bible camp and our group spent one of their days volunteering at Lighthouse Christian Home for individuals with disabilities. I almost forgot to mention getting drenched whitewater rafting. The youth and chaperones shared their experience with the congregation at worship service.

Ice Cream Social – This youth fundraiser and community event took place on Sunday, July 27th, from 12:00–5:00 p.m. and was made possible through the generous support of many adult members who helped coordinate the many details of this large St. Olaf gathering. Orders and payments (cash or charge) were taken in the Gathering Area, where guests received table numbers for food delivery. Both indoor and outdoor seating were available. A Car Show added to the festive atmosphere, featuring a variety of vintage vehicles on display, and live music by Garrett Monis and his band provided entertainment through the afternoon. We were truly blessed with beautiful weather and with food and supply donations from members that helped make the event a success. In total, the fundraiser raised \$3,200, minus expenses, toward our youth activities.

Bluegrass Festival – The youth had a food stand and sold sandwiches, beverages and ice cream during the Bluegrass Festival event on August 10th. Much of the food expenses for this event had already been purchased for the Ice Cream Social (and left over) or donated. Despite steady rain throughout the afternoon, our stand kept busy and we were able to raise an additional \$1000.

Box City – was held on October 4-5. Seven youth participated in Box City to raise awareness and support those experiencing homelessness. Youth structured boxes to sleep in, enjoyed a bonfire and activities, slept outside, and attended Sunday's service.

Thanksgiving Eve Worship – was led by the youth. Musicians included: Garrett Monis, Sally Pietz, Sam Pietz, Matthew Zagar and Brayson Brown. Chloe Monis helped with readings and Adia Gies read the prayers. Garrett Monis shared a message acknowledging that we are "Twice His".

Kids 'Christmas Workshop – On December 20 from 9:00-12:00, thirteen children joined in games, crafts, snacks and Christmas shopping as St. Olaf. Parents had a few hours off. Fun was had by all!

Report from Treasurer

During FY 2025, the Actual Expenses of the Church was \$241,686, which came in \$2075 under budget. The prior year we were \$1973 over budget. As a result, we have a year-end checking account balance of \$10,446 with \$25,318 in the General Fund Money market for a total of \$35,764. Last year, our EOY checking account balance was \$33,644 which is lower than this year's by \$2120.

The recommended budget for 2026 is \$223,197, a decrease in the budget by \$20,564 with one caveat. This is reflected in the opportunity to save money through a different health insurance option for Pastor Tom. We were given this opportunity through Kris' work for her school district, saving the church quite a bit of money as the health insurance from the Synod has gone up substantially. With this savings we would have the option of taking on an intern at St. Olaf's. While this has not happened yet, an intern would potentially cost the congregation app. \$1667 per month. For budgetary numbers, if we would take on an intern in the summer, this could cost the congregation \$10,000 for half of the year.

The balance of the staff was given a 2.8% raise based on COLA from Social Security.

Commitments for 2026 were app. \$196,000, compared to last year's \$217,000. While it is significant, we feel that the budget can be met with sustained giving.

General Offerings for Simply Giving were \$66,747, up \$5034 from last year, reflecting 28% of the income.

We had income of \$38,729 for the Mission Fund.

The Capital Fund increased from a balance of \$76,491 to \$77,530, for a total of \$1039. We had hail damage on the roof this year and received a large insurance settlement which was used along with other funds to finance a new roof for the church, garage and parsonage. Payment still needs to be made to complete the work. Siding was done on the fellowship hall. The prairie project was started. The Vision Fund has a balance of \$15,446 in the Holding Account Money Market. On October 1st, \$7300 was withdrawn to help fund the Mission Trip to Belize on January 17th. There is a \$104,230.85 balance in the 7-month CD at UW Credit Union which matures on February 16, 2026, with a current interest rate of 3.97%.

The Vision Fund, also, has a current balance of \$121,339.29 on 13.82% in the Ameriprise Investment account, which brings us a balance of \$241,016.14 EOY. With no upcoming immediate need for funds use beginning of 2026 and anticipated outlays in 2027 the need for Vision Fund investments can be delayed until next year. Our baseline for the Vision Fund last year was \$210,000. This year we would like to move the baseline to \$225,000 and move app. \$11,000 to the Money Market for available use, a total of UWCUCD-\$4230.85 + Ameriprise Investments-\$7000.00.

Children's Cup: \$8638 was given for the Marcus Canul projects.

Overall, St. Olaf's maintained funding for several different missions and operating expenses from the roofs on the church, garage and parsonage, church siding, prairie project landscaping. Also, funding for 2026 mission trips for the mission trip to Belize, and funding for equipment in Guatemala.

With an increase in Simply Giving (electronic ACH) and RMD (Required Minimum Distributions) we expect giving to be maintained and, hopefully, increase for our mission projects.

The checking account balance is virtually the same as last year at this time, but it is expected in 2026 that giving will increase slightly, though we may need other funds to meet the 2026 Budget.

The budget was decreased app. 9% as a savings opportunity was presented to us, however, it does give us an opportunity to expand into more mission work. With commitments down from the previous year there is a concern that though the budget is lower, we may need other funding opportunities to meet the mission needs of the church and the community.

The economic forecast for 2026 suggests that the economy is “K-shaped” where upper income earners are seeing a boon, whereas lower income earners are seeing their disposable income tighten. Prices may continue to rise with inflation and giving may be affected. However, there seems to be growth in certain sectors that may mitigate a downturn.

Report On 2025 Maple Syrup Season

For this 17th year of producing maple syrup, production was down, due to unfavorable weather conditions. Nevertheless, we made 48.4 GL Saintly Syrup. Net income was \$3,765, some of which was disbursed to Play4Cade (Rubicon), battling for S.O.S. (St. Olaf Sewers), VFW Oconomowoc for land purchase, and Dr. Martin Luther Church (for its members' syrup help). A balance remains in this account for any upcoming St. Olaf expenses. Total income 2009-2025 = \$72,834

Scrip Report

St. Olaf's can benefit greatly from your participation in the Scrip program. You pay exactly the same amount for food, gas, clothes, toys, etc. as you would at the gas station or store and St. Olaf's gets a percent of the sale! It is so easy. We carry an inventory of the most popular cards that you can pick up after church services. If you want cards for other than are available, fill out an order form. You'll have your cards the next weekend.

In 2025, the Scrip program brought in \$3,393.11 to St. Olafs. If all of our members would use this program for many of their regular household expenses, St. Olaf could raise up to \$10,000 a year for the St. Olaf Scholarship fund and Child Smile. What's stopping you?

Thrive Team Report

The Thrive Team is a group of St Olaf members who have learned a process called “The Examen” that was developed by St. Ignatius of Loyola hundreds of years ago. It teaches us how to daily prayerfully reflect and respond when listening for the signal of God’s voice in the midst of our lives, and the life of our church, St. Olaf.

This year we continued to promote small group ministries and events that would nurture relationships, provide opportunities to share our stories, strengthen our commitment to family ministry, and build connections in the community.

Following the success of the Kids’ Christmas Workshop, we hosted an Easter Egg-stravaganza for kids 3-12, featuring egg dyeing, Resurrection Egg project, baby goats, and Easter egg hunt the Saturday before Easter. About 20 children participated, and had a great time!

In March, the Sunday School kids planted seeds and seedlings in our new raised planters built by Herb & Kim Johnson at the end of our paver walkway. The vegetables and herbs they planted produced ‘much fruit’ and were harvested during the summer and fall and given to the All Peoples produce stand.

Again, in December, we hosted the Kids’ Christmas Workshop where 15 kids, 3-12, decorated cookies, made pinecone bird feeders, wrote Christmas cards, sang Christmas songs, and then ‘shopped’ and wrapped presents for family members, while moms & dads had the morning off. Thanks to all the teens and adults who helped the morning go so smoothly!

Randy Sikkema again led a group interested in the Daniel plan who met monthly to hike in nearby locations, and also is organizing regular opportunities for us to help prepare food for the weekly Sunday lunch program at Redeemer Church in Milwaukee.

Susie Grulke and her Fontanini group set up a display for the Christmas season in the north Gathering area, and have plans to display the entire collection in the Fellowship Hall this Spring.

Pr. Tom led a group called “Good Grief” for people experiencing grief in their lives. Several attendees were from outside the congregation, and all found support and insight in the time spent together.

If you haven’t had an opportunity to get to know people in a small group setting, please consider trying one of our many current opportunities that include weekly: Sunday pre-service coffee, Tuesday Men’s Bible Study, Searchers Bible Study, Wednesday Breakfast Group, Wednesday Maple Inn Fish Fry, Saturday post-service wine & cheese fellowship.

Monthly or ongoing options include: Brewed Omen men’s group, SOAR book club, property team work group, quilting group, maple syrup team, and Fontanini Bethlehem village display team.

As a result of our follow through with implementing the things we learned in the Examen training, we qualified for a small grant from the Lily Foundation. We will use these funds to continue to provide opportunities for us to develop closer relationships through small group ministry. Please keep the Thrive Team in your prayers as we continue to seek God’s will and the help of His Holy Spirit in this congregation so that our ministry to this community will thrive for years to come.

Prairie Project Report

Progress on the prairie project has begun. In the Spring we surveyed the congregation to assess the interest in this project and what aspects resonated with the most people. Almost unanimously the respondents were excited about an outdoor worship opportunity, plans for a 'natural' setting with areas for walking and meditation. There was strong support for development of a labyrinth and native plantings. A visual presentation of the plan was developed and displayed for the congregation to view. It is currently located in the southeast corner of the Fellowship Hall so that you can look out onto the area to help visualize our ideas.

To start off the project, in early summer Jim Lumsden planted 6 upright arbor vitae south of the metal collection trailer to screen it from the proposed worship area.

We informed the farmer that rents the field that we are planning to use a portion of the land to plant native grasses and flowers, and so the area was unplanted this summer. Mid-summer John Christenson and his crew mowed the area down, removed a scraggly box elder tree and cleaned up the retention/water drainage areas. A second mowing was done this Fall that included the garden area south of the parsonage. This area may be included as part of the prairie field.

In the summer Gavin Monis approached the council with plans to install a labyrinth on the southwest corner of the lawn area as his Eagle Scout project. His plans were approved and Gavin went to work! In early October he and his troop installed a labyrinth defined with inground pavers with a central cross. This approach will make maintenance simple, and we will enhance the area with benches for rest and reflection, and native shrubs for added privacy this year. Additionally, we are exploring signage to inform visitors on ways to incorporate the labyrinth in their prayer life.

Kristin Thiel has provided us with plans for the next steps: timing, techniques to use, resources that will be needed, and types of seed, shrubs, and trees that may be appropriate for the space. We will be purchasing her recommendation for native seed mixture this month and have plans to use a drill seeding method for our first seeding this Spring. Additional seedings will be done over the next 3-4 years with weed maintenance done as needed.

Plans to plant the retention/water drainage areas and swale with rain garden plants is being considered in May. If you have plants that would be appropriate for wet areas that you would be willing to donate to help with this project, please contact Mary Hershoff.

Future plans include building an arched entrance, a footbridge over the swale area, planting native berry bushes, shrubs and trees, and developing meditation areas with benches.

Thank you all for supporting this proposal, and we look forward to incorporating more of this natural space into our worship and community life.
